BUYER PRE-PURCHASE EXAMINATION AGREEMENT

Please fill out and return before appointment

Dear Buyer,

_____ (buyer), is the prospective purchaser or the agent assigned to purchase the horse named _____. The buyer acknowledges that Jacksonville Equine Associates / Southern Georgia Equine have agreed to perform a pre-purchase examination on the horse upon the guidelines of this agreement.

The exam is performed for the buyer and not the seller. It is the buyer's responsibility to inform the Veterinarian of the extent of examination and the selection of any diagnostic tests chosen. The Veterinarian who does the pre-purchase examination is not going to pass or fail the horse on the examination. The Veterinarian will provide you, the buyer, with the information regarding any existing medical problems and the horse's overall soundness and health condition on the given day of the examination. The examination is not to be used as a prognosis for future use. The decision on whether or not to purchase the horse examined is solely the buyer's choice and responsibility.

The buyer should be aware that this examination is not an in depth evaluation or opinion of the horse's temperament, ability, or aptitude for a particular discipline, or the value of the horse. A routine pre-purchase examination may not reveal subtle unsoundness, especially if the horse has not been in a consistent exercise program. The buyer should understand that there are limitations, and may not be seen by clinical, radiographic, and laboratory examinations, such as mild vision impairment, early Cushing's Disease, digestive disorders predisposing colic signs, muscle disorders such as equine polysaccharide storage myopathy, recurrent airway obstruction, neurological conditions such as CSM, EPM, cervical spine arthritis, and/or some boney/ligament disorders that would only be visible on a CT or MRI.

The buyer is responsible for complete payment of pre-purchase examination at the time the pre-purchase examination is ordered by Cash, Check, Visa, MasterCard, American Express, Discover, Care Credit by calling our office, or PayPal through our website at www.jaxequine.com.

Buyer acknowledges that this signed Buyer Pre-purchase Examination Agreement is to release, waive, discharge and dismiss Jacksonville Equine Associates / Southern Georgia Equine and all employees from any claims arising indirectly from the performance of the pre-purchase examination.

Our pre-purchase examination of your horse includes the following:

Pre-purchase Clinical and Moving Evaluation: \$300

The clinical examination begins with a comprehensive evaluation of the horse's respiratory, cardiovascular, musculoskeletal and gastrointestinal systems. A thorough palpation examination of all the limbs, neck and back is also performed. During the moving evaluation, the horse will be examined at a walk and trot on a firm surface, and lunged and/or observed under saddle at the walk, trot and canter in both directions. In addition, flexion tests of the forelimbs and hind limbs will be evaluated.

Please arrange for a competent rider and tack to be available for the exam

Digital Radiographic "X-Ray" Examination:

Following the moving examination, the horse will proceed to radiographs. It is standard in our x-ray examination, to remove the horse's front shoes in order to obtain the best quality radiographs of the front feet. More advanced diagnostics such as ultrasound may be indicated if swelling, thickening, or sensitivity of the tendons or ligaments is palpated.

- The Basic Pre-Purchase radiograph package: \$500.00
This includes the front feet/navicular bones and hocks (16 views) is offered at the discounted price.
- Hocks Left/Right (8 views) \$400.00
- Front Feet/Navicular Bones (8 views) \$400.00
- Front Fetlock / Ankle \$200 per limb left or right
- Hind Fetlock / Ankle \$200 per limb left or right
- Back / Dorsal Spine \$250.00
- Stifles (Strongly suggested for higher level competition and jumping horses) \$200 per limb
- Ultrasound if indicated (tendon, ligament, etc.) \$200.00(8views) \$400.00
If a full set of radiographs accompany the horse, and they will be used instead, there will be a \$300.00 radiographic consultation fee.

___ CBC/ Chemistry Blood Work: \$125.00

This blood panel provides information concerning muscle enzymes, kidney, liver, and other organ functions. (Please allow 2 working days for results).

___ Drug Screening: \$300.00

This urine test ensures that the horse has not been adulterated by medication prior to the pre-purchase exam. The screening tests for non-steroidal inflammatory drugs such as Bute, Banamine, ect., steroids, or short and long acting tranquilizers that may have been administered to the horse prior to examination. The results are usually back in 3-5 working days.

___ Upper Airway Endoscopy: \$250.00

This provides visual examination of the upper respiratory tract. This testing is strongly recommended for the horse competing in Hunter classes or if any abnormal respiratory noise is noted.

___ Gastroscopy: \$250.00

This provides visual examination of the esophageal tract along with inside of the stomach. This will show any signs of ulcer activity.

___ Coggins (EIA) Test: 5-7 days - \$35.00 Rush 3 days \$100.00

We highly suggest a new test.

___ Health Certificate: \$30.00

This is for the horse leaving or entering the state of FL.
